- 4.1 FIRST ORDER READ

Debate on Committee Stage – *Appropriation Bill* [B.1 – 2013] [**Votes: 01, 30, 04, 11, 03, 18 and 09**]

The Chairperson put the question: That he leaves the Chair.

Agreed to.

The Chairperson then called upon Vice-Chairperson of the National Council and the Chairperson of the Committee of the Whole Council to take the Chair.

The Vice-Chairperson of the National Council and the Chairperson of the Committee of the Whole Council then took the Chair.
