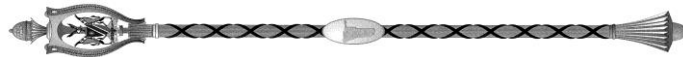


TENTH SESSION, FIFTH NATIONAL COUNCIL

3.0 DEBATE ON SECOND READING

3.1 FIRST ORDER

Debate on Second Reading – *Appropriation Amendment Bill* [B.18 – 2017].

4.1 SECOND ORDER READ
