**NOTICE OF A MOTION**

**I. Prime Minister:**

That this Assembly –

In accordance with Article 127 of the Constitution;

*Approves* the re-appointment by His Excellency the President, of Mr. Junias Etuna Kandjeke as Auditor-General of the Republic of Namibia for a further period of five years; as from 1 April 2018.

**ORDER OF THE DAY**

Resumption of Debate on Second Reading – *Appropriation Bill* [B. 2 – 2018] – [Deputy Minister for Marginalised People].

**NOTICES OF MOTIONS**

**II. Minister of Environment and Tourism:**

That leave be given to introduce a Bill to regulate the gambling and gambling activities in Namibia; to set out the principles for gambling and gambling activities; establish the Gambling Board; to establish the Gambling Trust Fund; and to provide for incidental matters.

**III. Minister of Environment and Tourism:**

That this Assembly –

*Discusses and adopts* the Report on the Implementation of the Environmental Management Act of 2007 (Act No. 7 of 2007) during 2016/17 financial year.

**IV. Mr. Muharukua:**

That this Assembly –

*Discusses* the constitutionality of the red-line and the socio-economic impact on the communities that live north thereof. Further, that the Motion be referred to the relevant Committee, to:

- (i) Determine the impact of the red-line in our communities;
- (ii) Determine various measures to mitigate any prejudices that occur to communities; and
- (iii) Craft an action plan towards the elimination of the red-line by the year 2022 as outlines in the NDP5.

That the Committee report back to this august House.

**V. Mr. Muharukua:**

That this Assembly –

*Discusses* the level of corruption in Namibia, its impact on our economy, and the effectiveness of the current efforts to deal with corruption.

Further, that this august House set up an ad-hoc committee mandated to investigate, interrogate the questions above, and report back to this august House with recommendations as to how to cleanse our nation of the evil of corruption.

**VI. Mr. Mbai:**

That this Assembly –

*Discusses* the issue of urbanization and its impact on our towns and cities.

There are various aspects that need to be carefully interrogated when dealing with this issue of our people migrating to towns and cities in search of better future. Indeed there are key questions that need to be answered, investigated and digested when dealing with these questions.

**VII. Mr. Van Wyk:**

That this Assembly –

*Discusses and Debates* possible measures to address the roaming of domestic animals along national and districts roads, causing accidents and the loss of human life.

**VIII. Mr. Murorua:**

That this Assembly –

*Discusses* the conditions under which a liquid that is brewed and sold for human consumption in our shanty townships by steaming or distilling old dirty clothes like underwear, boots, shoes and whatever dirty materials that bare available and which is confusing and poisoning our people on the grass-roots level;

- and the consumable hygiene of the materials that is used in this process; and
- that this matter be referred to a relevant Parliamentary Standing Committee for further investigation and reporting.

**IX. Mr. Venaani:**

That this Assembly –

- (i) *Discusses* value addition on all our extractive industries, more so the mining sector as means to stimulate unemployment and high foreign earnings.

African countries have exported basic raw materials, missing out on opportunities to turn basic ingredients into finished goods that can earn them more income.

Value addition is not economically exploited in Africa, making it difficult for the continent to grow. Namibia needs to invest in industrialization to create jobs as well as increase the foreign exchange.

Africa and indeed Namibia relies majorly on exporting its raw materials only to buy them back in the form of finished products.

- (ii) *Debates* the need to put a curb of 30% of products to be put through value addition.
- (iii) That this Motion be referred to the Parliamentary Standing Committee for further input.

**X. Mr. Kavekatora:**

That this Assembly –

*Discusses* and *debates* the relevancy of the continuous use of EVMs in our presidential, national, regional and local authority elections.

That this Motion, after debate in the House, be referred to the relevant Parliamentary Standing Committee for further investigation.
