





## STRENGTHENING SADC PARLIAMENTARY ENGAGEMENT IN THE BUDGET CYCLE

# FOCUS GROUP DISCUSSION FOR MEMBERS AND STAFF OF THE PARLIAMENT OF NAMIBIA

**Otjiwarongo, Namibia, 10 August 2016** – The Association of European Parliamentarians with Africa (AWEPA) is holding a focus group discussion with Members of the Namibian Parliament and secretariat staff on the project: *Strengthening SADC Parliamentary Engagement in the National Budget Cycle*. The focus group discussion is being hosted in Otjiwarongo, Namibia from 10 - 11 August 2016.

The project was initiated in response to the renewed appreciation amongst parliaments in the Southern African Development Community (SADC) to examine their engagement at all stages of the national budget process, which is a move towards effectively executing their oversight mandate. As a partner in the project, the Parliament of Namibia invited AWEPA to delve into its engagement in the budget process and collect data on its unique political, economic and social experiences from a parliamentary lens early this year. The data collected will serve as the foundation for continued dialogue on the subject as the project unfolds.

The focus group discussion in Otjiwarongo constitutes the first step in this process, inviting participants to engage with the wealth of information gathered and critically reflect on how the institution of parliament can enhance, influence and create innovative strategies for engagement in the national budget process. conclusions and recommendations emanating from this reflection will be elevated to the regional level in early 2017, where Members and staff of the Parliament of Namibia will have the opportunity to further reflect on their engagement in the budget process from a comparative perspective alongside participants from Lesotho, Zimbabwe, Malawi, Zambia and Botswana.
