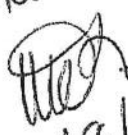

NOTICE

This Bill to be submitted to the National Assembly is released to the public for notice, comments, debates and general discourse necessary for the decisive legislation to solve the land question at the legislative level

BILL

To provide for the Regulation of Foreign Ownership of Land; to fulfill the directives and objectives of Article 16 (1) of the Namibian Constitution, to regulate the right to acquire property by persons who are not Namibian citizens; to reaffirm and give power, control and ownership of the land in Namibia, to the people of Namibia and to provide for incidental matters.

CHAPTER 1

INTRODUCTORY PROVISIONS

Definitions

- 1. In this Act, unless the context indicates otherwise -

"*Foreign national*" shall mean a person who is not a Namibian citizen as defined by Article 4 of the Namibian Constitution.

"*Lease*" shall mean an agreement whereby the state leases land, to a foreign national for a period not exceeding the period of ten (10) years, renewable subject to the fulfilment of the conditions prescribed in the act or any other laws;

"*Namibian*" shall mean any person who is a citizen as envisaged by Article 4 of the Namibian Constitution read with the Citizenship Act, 1990 (Act 14 of 1990);

"*Minister*" shall mean the Minister responsible for land in Namibia;

"*Agricultural land*" shall have the same meaning as defined in the Agricultural (Commercial) Land Reform Act 6 of 1995;

"*Communal Land*" shall have the same meaning as defined in the Communal Land Reform Act 5 of 2002;

Application of Act

2. This Act applies to all land that forms part of the territory of the Republic of Namibia whether owned by the State or private individuals.

The Object of the Act

3. (1) Parliament may by legislation prohibit or regulate as it deems expedient the right to acquire property by persons who are not Namibian citizens.

(2) The objective of this act are;—

- (a) To prohibit ownership of any land in Namibia by a foreign national
- (b) To serve as an enable for the government and the state including any of its agencies to regulate land ownership in Namibia in relation to foreign Nationals.
- (c) To ensure and allocate land to Namibians in general and indigenous Namibians in particular
- (d) To ensure that, through this act or regulations made in pursuance of this Act, existing land ownership by foreign nationals is controlled and regulated as envisaged in this Act.

CHAPTER 2

ORIENTATION TOWARDS THE LAND QUESTION

PART 1

THE STATE AS THE CUSTODIAN OF THE LAND

Prohibition of ownership of land by foreign nationals

4. (1) No land in Namibia shall be owned by a Foreign National.

(2) Foreign nationals may only utilize land in Namibia, subject to Section 6 of this Act.

Conditions and circumstances of utilization of land by foreign nationals

5. (1) Foreign nationals may utilize land in Namibia under the following conditions;

(a) Lease for purposes of economic development, provided that;

(i) Such foreign national is in partnership with a Namibian Citizen, in which partnership the Namibian Citizen must not have less than 51% ownership;

(ii) The effective control and management of the partnership which partnership may be in the form of any recognized juristic personality is in the hands of the Namibian Citizen;

(b) The lease agreement as envisaged in section 5(1)(a) above may only be concluded after the partnership has made an application in a prescribed form to Cabinet and cabinet. Cabinet must consider the application, and if it is of the view that the applicant will bring economic benefit to Namibia, cabinet must submit that application for tabling and approval by the Parliament.

(2). Foreign nationals may only lease the land as envisaged in section 5(1) for commercial purposes, and are specifically prohibited from leasing any agricultural land or any communal land.

(3) No lease period exceeding a period of 10 years shall be valid. However the lease agreement may be renewed upon application by the partnership.



PART 2

EXISTING OWNERSHIP OF LAND BY FOREIGN NATIONALS

Urban Land

6. (1) If urban land is lawfully owned by foreign nationals prior to the commencement of this act, such land shall remain owned by the foreign national.

(2) Such urban land that is lawfully owned by a foreign national prior to the commencement of this Act shall not be sold, transferred or bequeathed to another foreign national after the commencement of this act. Ownership or transfer thereafter can only be effected to a Namibian National.

Agricultural Commercial Land

7. (1) Agricultural commercial land that is owned by foreign nationals prior to the commencement of this act shall be expropriated by the state within three years from the date of the commencement of this act, in accordance with existing laws .

(2) However a Foreign nationals who enter into a partnership with a Namibian national after the commencement of this act, which partnership has the effect of reducing the foreign national ownership into the land to not more than 49% and transfer not less than 50% ownership to a



Namibian, who shall be a previously disadvantaged Namibians as defined by the Affirmative Action Act shall not be subjected to expropriation.

(3) the reassignment of percentage ownership in subsection two shall comply with the provisions of the Agricultural (Commercial) Land reform Act.

Communal Land

8. Communal land is governed through customary land rights that are guaranteed by the constitution. As such –

(1) No foreign national is allowed to utilize communal land for any purpose.

(2) Any allocation of communal land to a foreign national before this act shall be deemed to have been an illegal transaction and shall be repudiated.

CHAPTER 3

GENERAL PROVISIONS

Expropriation of Land

9. If it is in the public interest and in attainment of the objective of this act – and to allow for ownership of land by Namibians in general and indigenous Namibians in particular, the state shall Expropriate urban land owned by foreign nationals in the public interests.

Status as primary subordinate legislation

10. Because this act fulfilled an outstanding addition to a fundamental right to the Namibian Constitution, it shall be regarded as a primary legislation in so far as it may conflict with any other laws.

Protection of from proceedings in foreign courts

11. (1) In adherence and pursuance to Article 1 (2) of the Namibian Constitution, this act shall not be a subject of proceedings in any foreign court or tribunal.

(2) All disputes arising from any provision of this act shall be adjudicated in the Republic of Namibia in accordance to the laws of Namibia.

Short title and commencement

12. This Act is called the Regulation of Land Ownership by Foreign Nationals Act, 2019, and comes into operation on a date to be determined by the Minister by notice in the government Gazette

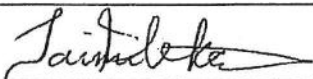
