REPUBLIC OF NAMIBIA ORDER PAPER OF THE NATIONAL ASSEMBLY

WEDNESDAY, 13 SEPTEMBER 2023 (14:30 – 17:45)

NOTICES OF MOTIONS

I. Deputy Minister of Works and Transport:

That this Assembly -

Discusses the possibility that Namibia Student Financial Assistance Fund (NSFAF) incentivize loan beneficiaries with the aim to stimulate entrepreneurship and job creation.

II. Hon. Mukwiilongo:

That this Assembly –

Discusses democracy's success and relevance for Namibia aimed to critically assess whether democracy has effectively served Namibian interests, contributed to the cultivation of a robust and accountable political leadership landscape, and genuinely represented the collective will of the majority of our fellow Namibians

III. Hon. Vries:

That this Assembly –

Debates the food security situation in Namibia, its impact on the livelihoods of Namibians and seek urgent interventions to ensure food security situation in Namibia.

That the Motion be referred to a relevant Parliamentary Stranding Committee to propose recommendations to this august House after conducting diligent work on the subject matter. Finally, that the relevant Parliamentary Standing Committee, in conformity with the rule be encouraged to have associate Members of Parliament contribute to its work.

IV. Hon. Hamata:

Long distance marriages can be pretty daunting. They can take a toll on the mental and physical health of spouses and their children.

All children have the right to grow up with both their parents, in the same environment. Children in family environments are generally safer and better cared for, yet things like long-distance marriages force hundreds of children from their biological parents each year and vice versa. These spouses and children suffer extreme stress when split from each other for months, sometimes years on end. Separation undermines children's development. What's more, it leaves them vulnerable to violence, exploitation and abuse.

Article 14(3) of our Constitution makes provision for the family being the natural and fundamental group unit of society, and is entitled to protection by society and the State.

That this Assembly therefore –

Discusses the issue of family separation due to long-distance marriages and the negative impacts this has on the psychological health and financial status of families as they now have to struggle to keep up with maintain two households in different towns, or regions.

Further, that this Motion be referred to a relevant Parliamentary Stranding Committee for further investigation and informed counsel.

Discusses the plight of the small-scale miners in the Erongo Region.

Further, that this Motion be referred to a relevant Parliamentary Standing Committee.

III. Hon. Moongo:

Pregnancy and maternity are potentially vulnerable time for working women and their families. Expectant mothers and fathers, and nursing mothers require special protection to prevent any potential adverse effects for them and their infants.

That this House therefore -

Discusses the possibility of increasing the amount payable in respect of maternity leave, extending maternity leave duration up to five months will full pay, and including paternity leave in the legislative framework.

That this Motion be referred to a relevant Parliamentary Standing Committee for further inquiry and report back to this Assembly.
