1. INTRODUCTION

(a) In the foreword to the document, entitled:

<u>DEVELOPMENT PROGRAMMES: MEDIUM - TERM</u> EXPENDITURE FRAMEWORK, 2024/25 – 2026/27;

Director General of the National Planning the Commission, the Honourable Obeth Kandjoze, amongst others articulates the following: "One of the most important functions of the Government is to construct and maintain public infrastructure, across sectors countrywide. Most of the Government investment in Namibia is presented in the Development Budget Book, which is a critical tool in the National Development Process, as it indicates both public and development partners funding in policies, programmes and projects. Development Budget provides Citizens with information on the exact amount of public funds, for investment, aimed at boosting their livelihoods, welfare and prosperity. A thorough reading of this document enables the Public to monitor the utilization of funds and hold those responsible for the implementation



accountable, I, therefore, implore all entrusted implementing institutions to strictly ensure that: what is allocated to the various programmes and projects is executed in a <u>cost effective</u> and <u>efficient manner</u> to realize our national set goals and objectives." (<u>page iv</u>).

- (b) The specific transport projects, with their proposed and/or estimated funding, are lucidly articulated from page 340 to page 396 of the Development Programmes Medium-Term Expenditure Framework, 2024/25 2026/27. I implore and kindly request my Colleaques, all the Honourable Members of the National Assembly, to pay attention to the Projects, as listed on those mentioned pages, particularly during the Committee Stage consideration and discussion.
- (c) From pages <u>562 590</u> of the <u>DEVELOPMENT</u> <u>PROGRAMMES MEDIUM TERM EXPENDITURE</u> <u>FRAMEWORK 2024/25 2026/27</u>; specific factual information with regard to the <u>classification</u> of the different Capital Projects, Development and Investment Estimates by individual administrative Regions; including the Transport Capital Projects, is provided.

- Vote 24: Department of Transport, has the following Programmes; (pp 342-343):
 - (a) Infrastructure Development;
 - (b) Roads Infrastructure;
 - (c) Maritime Infrastructure Development;
 - (d) Airports Infrastructure;
 - (e) Railway Network Development;
 - (f) Public Works and Pubic Property/Asset Management. Construction, Rehabilitation and upgrading of Government Garages Nationwide.
- A total amount of <u>THREE BILLION</u>, <u>TWO FOUR NINE</u> <u>MILLION AND EIGHT FIVE FOUR HUNDRED</u> Namibian Dollars (N\$3 249 854,00); has been allocated to <u>VOTE 24</u>: <u>TRANSPORT</u>, during or for the Financial Year 2024/25.

4. CONCLUDING REMARKS

(a) Namibia is a very big Country, geographically speaking; with a relatively small population of <u>THREE MILLION</u>; according to the recently released National Census data.
