# REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE

# NATIONAL ASSEMBLY

# **TUESDAY, 17 SEPTEMBER 2024**

The Assembly met pursuant to the adjournment.

- 1. The Speaker took the Chair and read the Prayer and Affirmation.
- 2. Announcements by the Speaker in terms of Rule 117(b) of the Standing Rules and Orders:

The Speaker announced to the House that with the resignation of Honourable Erastus Shuumbwa of the All Peoples Party (APP) from the National Assembly a vacancy has occurred and that Honourable Linus Muchila was nominated to fill the vacancy in terms of Article 48(2) of the Namibian Constitution. The Honourable Muchila was sworn-in by Justice Dave Smuts on Friday, 13 September 2024 and as such is now a duly elected Member of the National Assembly.

The House collective welcomed Honourable Linus Muchila, as a Member of the National Assembly.

Secondly, the Speaker brought to the attention of the House, that in consideration of the upcoming Presidential and National Assembly elections, which is in the public interest and due regard to the Standing Rules and Orders of the National Assembly, in particular Rules 5, 8 and 12, as well as Article 62(2) of the Namibian Constitution, a consultative meeting was convened with the Party Whips, to which it was agreed that this Assembly adjourns on Thursday, 19 September 2024 and resumes again on Monday, 28 October 2024 for the continuation of the Tenth Session.

The House so agreed.

# 4. Ministerial Statements in terms of Rule 136 of the Standing Rules and Orders:

The Minister of Agriculture, Water and Land Reform made a brief Ministerial Statement on the Status of the Repatriation of Namibians from Botswana. He added that the citizenship of these communities has been implemented and as a result, ninety-eight (98) of them are expected to be received at the Dobe Border Post on Friday, 20 September 2024.

The Minister of Finance and Public Enterprises announced to the House and the nation at large that the various tax legislation amendments as deliberated on and subsequently passed by the National Assembly in August 2024, have been signed into law by His Excellency the President and were published in the Government Gazette on Monday, 16 September 2024. The specific Acts are as follows:

- (i) Income Tax Amendment Act, 2024 (Act No. 4 of 2024);
- (ii) Value-Added Tax Amendment Act, 2024 (Act No. 5 of 2024);
- (iii) Transfer Duty Amendment Act, 2024 (Act No. 6 of 2024); and
- (iv) Stamp Duties Amendment Act, 2024 (Act No. 7 of 2024).

The Minister continued to provide additional clarity specifically on the implementation of the Income Tax Amendment Act, 2024 (Act No. 4 of 2024) – in particular, the adjustment pertaining to the increase of the threshold for Income Tax on Individuals from N\$50,000 to N\$100,000.
