REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE

NATIONAL ASSEMBLY

WEDNESDAY, 18 SEPTEMBER 2024

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.

2. FIRST NOTICE OF A MOTION:

Deputy Prime Minister and Minister of Works and Transport moved, seconded by Rt. Hon. Prime Minister:

That this Assembly –

In accordance with Article 112(3) of the Namibian Constitution;

Approve the appointment by His Excellency the President of Ms. Ludmilla Habbatte Doeses and Mr. Michael Mutonga as members of the Public Service Commission for a period of five years.

Question put: That the Motion be agreed to.

Agreed to.

3. **FIRST ORDER READ:**

Third Reading – *Civil Registration and Identification Bill* [B. 8 – 2024].

Questions before the Assembly on Yesterday, 18 September 2024, as moved by the Deputy Minister of Home Affairs, Immigration, Safety and Security (page 145).

Question put: That the Bill be read a Third Time.

Agreed to.
