Namibia's industrialization efforts are influenced by the broader global economic landscape and therefore our space in International and regional political economy should be guided by agreements and protocols such as the African Continental Free Trade Area (AfCFTA) agreement which was signed in 2018 and ratified in February 2019. Subsequently on 21 November 2022, Namibia officially launched Namibia's National Strategy and Implementation Plan for the Agreement Establishing the African Continental Free Trade Area (AfCFTA) for the period 2022-2027, enhance domestic production capacities aiming to competitiveness. However, challenges such as inadequate infrastructure, skilled labour shortages, and competition from more industrialized nations must be addressed to fully realize the benefits African continental Free Trade Area. of AfCFTA. Strategic investments in infrastructure, capacity building, and policy reforms are essential for Namibia to leverage AFCFTA African Continental Free Trade Arca: effectively and achieve its industrialisation goals.
