REPUBLIC OF NAMIBIA MINUTES OF PROCEEDINGS OF THE

NATIONAL ASSEMBLY

TUESDAY, 8 JULY 2025

The Assembly met pursuant to the adjournment.

- 1. The Speaker took the Chair and read the Prayer and Affirmation.
- 2. Announcement by the Speaker in terms of Rule 117(b) of the Standing Rules and Orders:

The Speaker announced that His Excellency Narendra Modi, the Prime Minister of the Republic of India, will address the House on Wednesday, 9 July 2025, at 16:00, in accordance with Rule 224 of the Standing Rules and Orders, as a visiting dignitary of the Assembly.

The House is also informed that the business of the Assembly will proceed tomorrow as scheduled from 14:30, and by 16:00, the proceedings will be suspended in order for the Speaker to invite the Prime Minister into the Chamber to address the House.

5. Ministerial Statement in terms of Rule 136 of the Standing Rules and Orders:

The Deputy Minister of Education, Innovation, Youth, Sports, Arts and Culture delivered a Ministerial Statement regarding a Petition submitted by unemployed graduate teachers in Namibia. The House and the nation at large were informed that the Minister had acknowledged receipt of the Petition and assured that the matter is receiving urgent attention. An official acknowledgement has been issued to the petitioners, and a comprehensive response is scheduled to be submitted by 22 July 2025.

The Statement also highlighted the Ministry's implementation of a three-year plan, launched in May 2025, aimed at decongesting public schools. This phased initiative is designed to address critical challenges relating to teacher shortages and overcrowded classrooms.
